

Cookie Policy

Scope

The SpectrAxe Cookie Policy (Policy) provides information about how and when SpectrAxe uses cookies. Please see Appendix A to view which cookies SpectrAxe uses for its website and the reason for the use of such cookies. For purposes of this Policy, “SpectrAxe”, “we”, “us”, “our”, “its” refers only to SpectrAxe, LLC.

What is a cookie?

Cookies are small text files sent by us to your computer or mobile device, which enable SpectrAxe features and functionality. They are unique to your account or your browser.

Does SpectrAxe use cookies?

Yes. SpectrAxe uses both session-based (essential) and persistent cookies. SpectrAxe sets cookies on the domains operated on www.spectraxe.com and www.spectraxesef.com. Session-based cookies last only while your browser is open and are automatically deleted when you close your browser. Persistent cookies last until you or your browser deletes them or until they expire.

How is SpectrAxe using cookies?

SpectrAxe mainly uses cookies for the proper functionality and security of our website. SpectrAxe may use other cookies for analytics and customization of our website, as needed. Any cookies that would be used for such purposes would be shown below in Appendix A. SpectrAxe may also use cookies to recognize when you visit our website, to remember your preferences, and to give you a personalized experience that is consistent with your settings.

What can you do if you don't want cookies to be set or want them to be removed?

When you first access our website, a Cookie Banner will appear and allow you to set your cookie preferences and view cookies that SpectrAxe is using or would like to use on our website. Essential and necessary cookies will be automatically placed on your browser, unless you have already disabled the placement of cookies before accessing our website. Once they have been placed on your browser, you can remove them. Removing any necessary or essential cookies may cause our website not to function properly. The removal of any cookies, including third-party cookies, is fairly easy and accessible in your browser settings.

Please note that once a cookie has been placed on your browser, only disabling a cookie or category of cookies through your privacy and security settings on your browser may not fully delete the cookie from your browser. You may need to delete the cookie manually from your browser too since it was already placed there prior to disabling, and most likely delete it from your browser's history.
